Memorial Assistance Ministries' (MAM) mission is to assure that families have the means to meet their basic needs. To carry out our mission, MAM assists families facing financial crisis to avoid homelessness. MAM offers programs to enable long term financial self-sufficiency; to assure children have an improved school experience; and to facilitate client access to other support networks.

With Homelessness Prevention and Rapid Re-housing Program funds and private foundation funds, MAM began a Case Management Program in 2009. The program is described in Self-Sufficiency Programs below.

Form 990, Part III, Line 4a - Program Service Accomplishments

MAM offers FAMILY EMERGENCY ASSISTANCE to help families facing financial crisis avoid homelessness. This program includes: Shelter and Utility, Medical/Health, Food/Household, and Clothing/Transportation. Shelter and Utility assistance helped to prevent eviction for 1,891 clients. In many cases this means that the primary wage earner will spend less time seeking assistance and more time earning a salary.

Children are able to stay in the school where they are enrolled, rather than transferring midyear. Qualified clients receive a pledge and the funds are paid directly to the landlord or utility (gas and water) company. Medical/Health assisted 732 clients who received financial assistance to help pay for a doctor or dentist visit, or a prescription. Urgent health care can reduce workplace absenteeism, a root cause of unemployment and reduced wages and prevent more expensive emergency room visits. Food/Household assistance provided 697 sack lunches and MAM partners with two area food pantries to alleviate hunger, provided families home care packs with cleaning and toiletry items to relieve household expenses. Clothing/Transportation:

Families also qualify for clothing and transportation for work, job search or medical

care. The MAM Resale Store distributes clothing and household items at no cost to residents in our service area who have limited income and cannot meet their basic needs without support. The store is staffed with 75 regular MAM volunteers, serves as a site for court ordered community service and local volunteer organizations.

Students from MAM English as a Second Language Program also volunteer in order to improve their speaking ability.

Transportation/Other: People seeking jobs were given Metro money or gasoline vouchers to go to an interview, and, in some cases, to go to work until they received a first paycheck. The same transportation assistance is given to clients needing help getting to a doctor, dentist or pharmacy. MAM served 872 clients this way. MAM helped 263 people pay for documents necessary to find work, enroll children in school, etc.

These included driver's licenses, birth certificates, and state ID cards. 1,021 clients received additional miscellaneous help with things such as personal grooming aids, home care packs or vouchers to buy specialty items deemed necessary.

MAM's SELF-SUFFICIENCY PROGRAMS position families to meet their basic needs on their own with improved employment, financial coaching and English language skills. Heads of households in crisis become engaged in stabilizing their lives with access to Employment Services, Case Management, English as a Second Language and complementary programs provided at MAM by partner organizations. MAM assisted 1,354 people seeking employment in 2009 by providing them with the education, tools, and support needed to obtain gainful employment plans in order to stabilize the family. Case Managers work with families to develop a self-sufficiency plan that includes MAM financial assistance in decreasing amounts as family budgets become balanced. The Case Manager also coordinates public benefits and other social service resources for families in need. Case Managers worked with 234 families in 2009. MAM partners with another

non-profit agency to provide housing and case management for homeless families with children. English as a Second Language offers 5 levels of basic and vocational english classes to adult learners. 405 adults enrolled in 2009 and 241 students completed their courses. Complementary programs offered at MAM included free income tax services (1,301 returns with gross refunds totaling \$1,903,464), enrollment in public benefits (3,109 clients assisted in SNAP, Medicaid, CHIP registration), mental health counseling (40 individuals had 281 sessions), Immunizations (129) and health screenings (292), GED (35 learners), and financial literacy (122 clients).

PROGRAMS FOR CHILDREN IN SCHOOLS are designed to improved school experience for children from families with limited financial means and social networks. Back to School provided 2,725 school children in Spring Branch ISD with uniforms and in-kind school supplies for Aldine ISD. I Can See provided vision testing and glasses for 437 school children. 462 children from 159 families celebrated Christmas with gifts and food from Christmas Share. MAM is a registration site for CHIP and regularly offers immunizations. School nurses routinely refer sick children for doctor visits and prescription care. MAM runs a summer jobs program for eighth grade graduates who will attend high school in the fall. The students have job assignments but also benefit from workplace mentors, enrichment workshops and opportunities to visit area worksites to help the student begin to develop a career path.
